



## Raffle/Opportunity Drawing Terms and Conditions

The raffle/opportunity drawing prize is YOUR CHOICE of: (A) a 1971 black and gold restored **ROLLS ROYCE SILVER SHADOW**, (pictured on reverse) available for inspection in San Carlos by contacting Black Mountain Properties LLC at 650.595-8452; **OR** (B) a series of five (5) dance lessons at the mutual convenience of all parties to be provided by Jonathan Roberts and Anna Trebunskaya ("Stars") (both have appeared on "**Dancing with the Stars**"). Lessons are to be in San Mateo or Santa Clara County at a location selected by the Stars in consultation with winner. This is an opportunity drawing so there may be tickets issued by those who refuse to donate but demand a ticket. Such sales and ticket issuances will affect the odds of winning. Purchasers must be 18 years old or older.
